IMPORTANT REMINDERS

If the delinquent date falls on a Saturday, Sunday or legal holiday, no penalty is charged if payment is made by 5 PM on the next business day.

If a check is not honored by the bank, the tax payment is null and void and a \$50.00 RETURNED CHECK FEE will be charged.

No notice or tax bill will be mailed for the second installment payment. Please mark your calendar.

Filing an application for reduced assessment does not relieve the applicant from the obligations to pay the taxes before the applicable delinquent dates shown on the tax bill. If a reduction is granted, a refund of taxes will be made.

Supplemental tax bills are issued following a change in ownership or completion of new construction. THIS TAX BILL DOES NOT REPLACE THE REGULAR TAX BILL WHICH IS STILL PAYABLE BEFORE DECEMBER 10 AND APRIL 10.

The entire tax amount may be paid when the first installment is due. The second installment amount may be paid separately only if the first installment amount has been paid.

Payments made for less than the installment amount due are not acceptable and will be returned to the taxpayer.
